Competitive Trail Ride – Form

Definition: Distance trail rides judged within mandated time limits on natural terrain and points being based on the physical condition, behavior, etc. of the horse before, during and after completion of the ride by ride officials.

Rules:

- 1) Horses must be registered with the Spanish Mustang Registry, Inc. during the entire point season for which points are submitted. If more than one horse is ridden, make a sheet for each horse..
- 2) The owner of the horse must be an up to date member of the organization and any points earned during a period in which the owner is not a member will not be utilized in the compilation of points for the season.
- 3) The person named as the owner on the point form must be the person who is named as owner on the horse's registration per official SMR records.
- 4) Riders do not need to be members of the organization.
- 5) All Competitive Trail (CTR) points must be accumulated on rides sanctioned by the North American Trail Ride Conference (NATRC) guidelines or similar organization that follows NATRC guidelines such as the South East Distance Riders Association (SEDRA), Eastern Competitive Trail Ride Association (ECTRA), etc.
- 6) Weight divisions are recognized categories.
- 7) No distance under 15 miles per day will be recognized. Novice and Competitive Pleasure rides are 15-20 miles per day for a one day ride or 30-40 miles for a two day ride. In the Open division a type "B" ride (one day) ride will be 25-35 miles , a type "A" (two day) ride will be 50-60 miles and a type "AA" (three day) will be 80-90 miles.
- 8) Ride manager signature or official printout of ride results must accompany form.
- 9) All point forms are due to the Points and Awards coordinator by February 1st.

Points are as follows:

Distance:	0.2 points per mile
1 st Place	6 points
2 nd Place	5 points
3 rd Place	4 points
4 th Place	3 points
5 th Place	2 points
6 th Place	1 point
Sweepstakes winner	10 points

Completion points:

One day rides	No additional points
Two day rides	2 points
Three day rides	4 points
